In 1970 i had my first Bedlington-Terrier. Since 1986 I`m also an owner of Greyhounds.

My own breeding of Bedlingtons startet in the beginning of the 70`s. Over the years i breed a lot of Bedlington-terrier champions

My accomplishment as a judge began in 1976. In 1980 I got my permission as a judge for some breeds of terriers. I carried on my study for all breeds of terriers in the following years.

Since 1990 I am a groupjudge for all terriers of the FCI - Group 3 and Black-Terriers FCI - Group 2

In connection I started my accomplishment concerning the FCI-Group 10 (Sighthounds), finished This Group 1994 and Group 5 end of 1998, Group 9 i am finished end of 1999 All breeds and Groups I`m judging on CC-level, incl. BIS and Breeders Groups ect., best Junior, best Veterans

Since 1980 I judged a lot of Exhibitions in Germany and foreign countries. Until howadays I have been invited inca. 35 different coutries and have judged World, European-Winner and any Main-Shows more.

Prvo bih željela istaknuti da je proces postanka suca u Njemačkoj, odnosno unutar VDH-a i njegovih članica, iznimno dugotrajan i zahtjevan. Ispiti iz anatomije su obavezni, a glavni uvjet uopće da bi se moglo polagati ispit jest da ste prethodno imali uspješan uzgoj vlastitih pasa, odnosno da su psi iz vašeg uzgoja postali šampioni.

1970. godine sam kupila svog prvog Bedlington terijera, a od 1986.godine sam vlasnik i Greyhonda.

Svoj uzgoj Bedlington terijera sam započela još ranih 70-tih te se mogu pohvaliti mnogobrojnim šampionima te pasmine.

Svoj sudački put sam započela 1976. godine dok sam licencu za suđenje dobila 1980. godine prvotno za par terijerskih pasmina. Kroz nekoliko sljedećih godina sam učila i polagala ispite za ostale pasmine iz FCI grupe III i Crnog ruskog terijera iz FCI II za koje sam ispit položila 1990.godine.

1994. godine sam dobilu licencu za suđenje X FCI grupe, 1998. za FCI grupu V, a grupu IX sam položila krajem 1999.godine. Imam dozvolu za suđenje BIS-a, uzgojnih skupina, Najljepšeg mladog psa te veterana.

Od 1980. godine sam imala čast suditi mnoge izložbe u Njemačkoj te van granice. Do sada sam sudila u otprilike 35 zemalja te na mnogim svjetskim i europskim izložbama.
